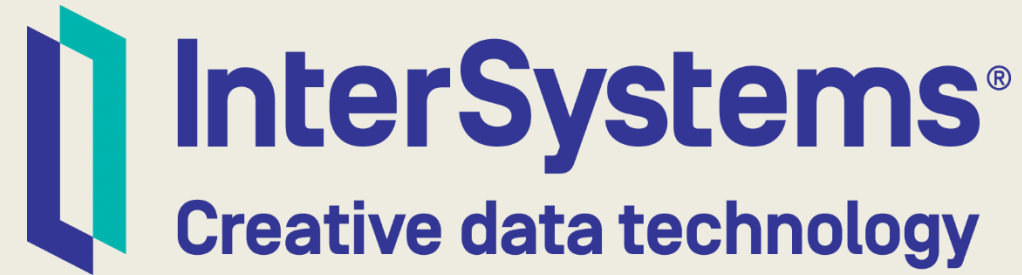

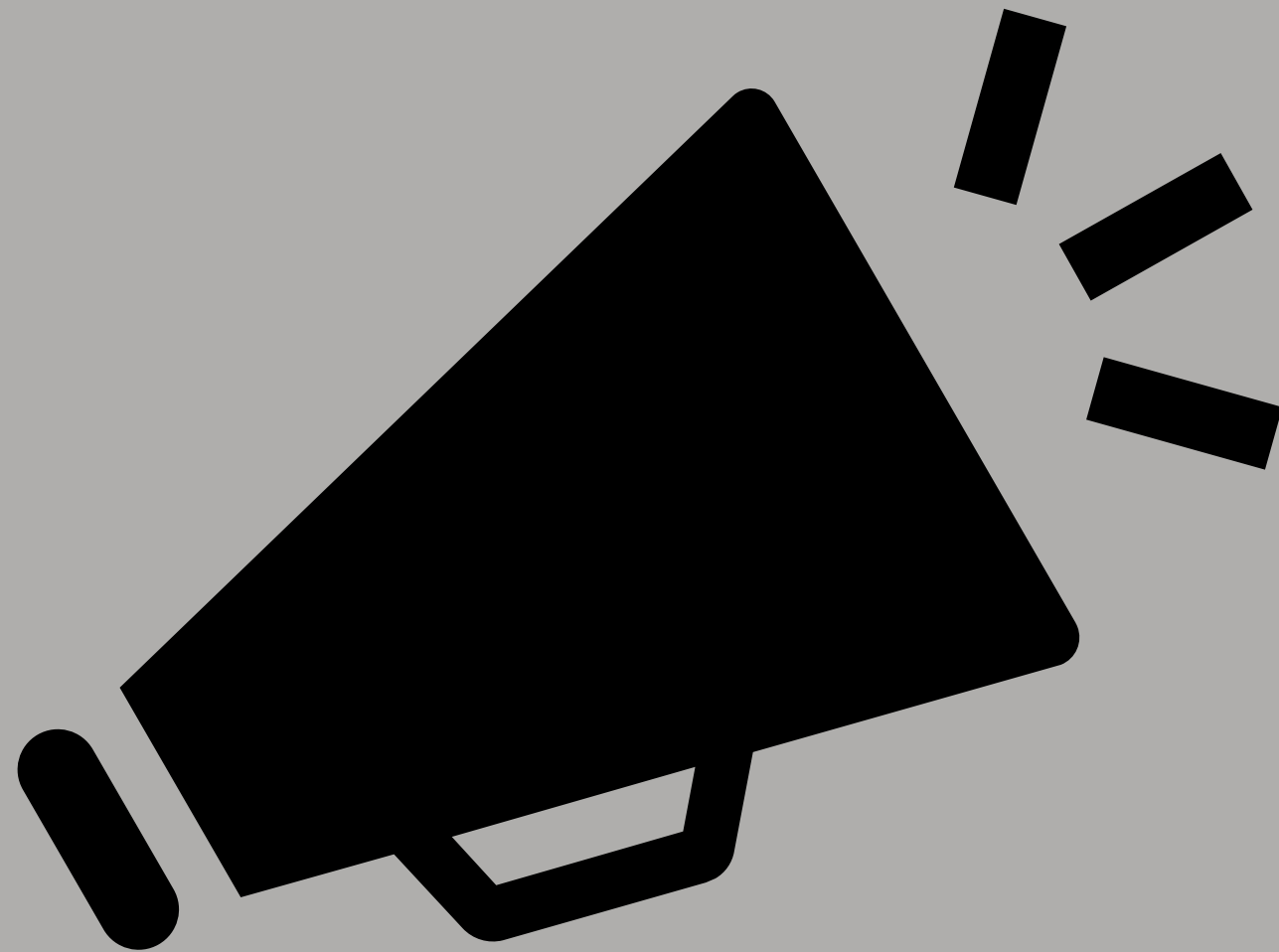

Civitas' CY25 PFS Comments

- Our PFS interest is driven by member involvement in the community care hub model of value-based care coordination, which builds regional and local referral networks through CHWs, shared data, and outcomes payments. Our recommendations to CMS are as follows:
 - The proposed advanced primary care management (APCM) capitated billing codes are a great step forward, but their required “service elements” should include HRSN/SDOH data collection and evaluation (tools/standards to use could be AHC HRSN, PRAPARE, NCQA SNS-e, or Gravity)
 - The CHI, PIN and SDOH-RA code set introduced last year and the APCM codes proposed this year should coexist for maximum care hub flexibility & revenue
 - The HRSN codes’ “initiating visit” requirement is still an operational problem for the care hub model that reduces its effectiveness; it should have a retroactive option and/or an expanded “established patient” category like the APCM codes

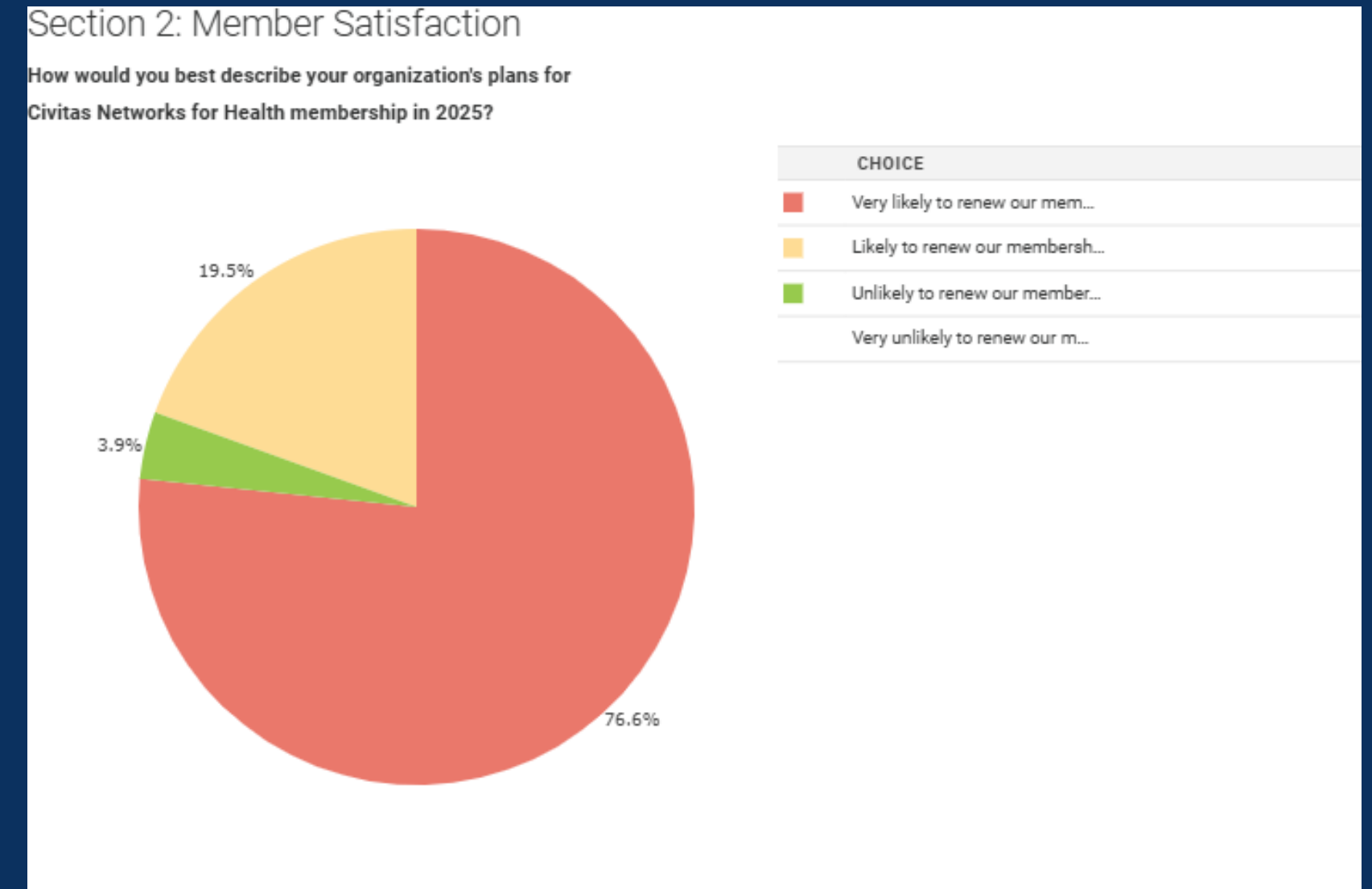
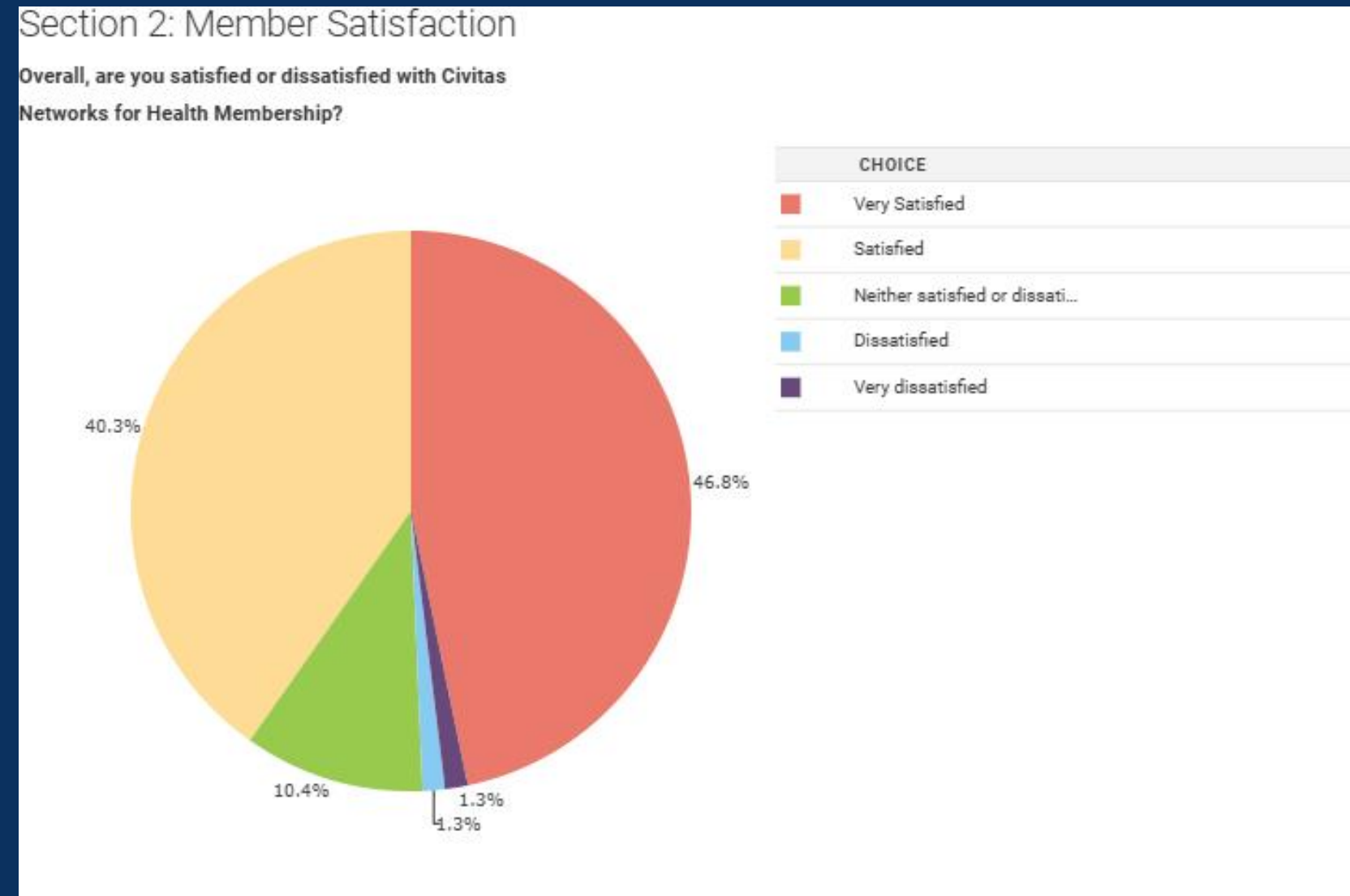




Member Satisfaction Survey | Preview of Feedback

Member Satisfaction Survey | Preview of Feedback

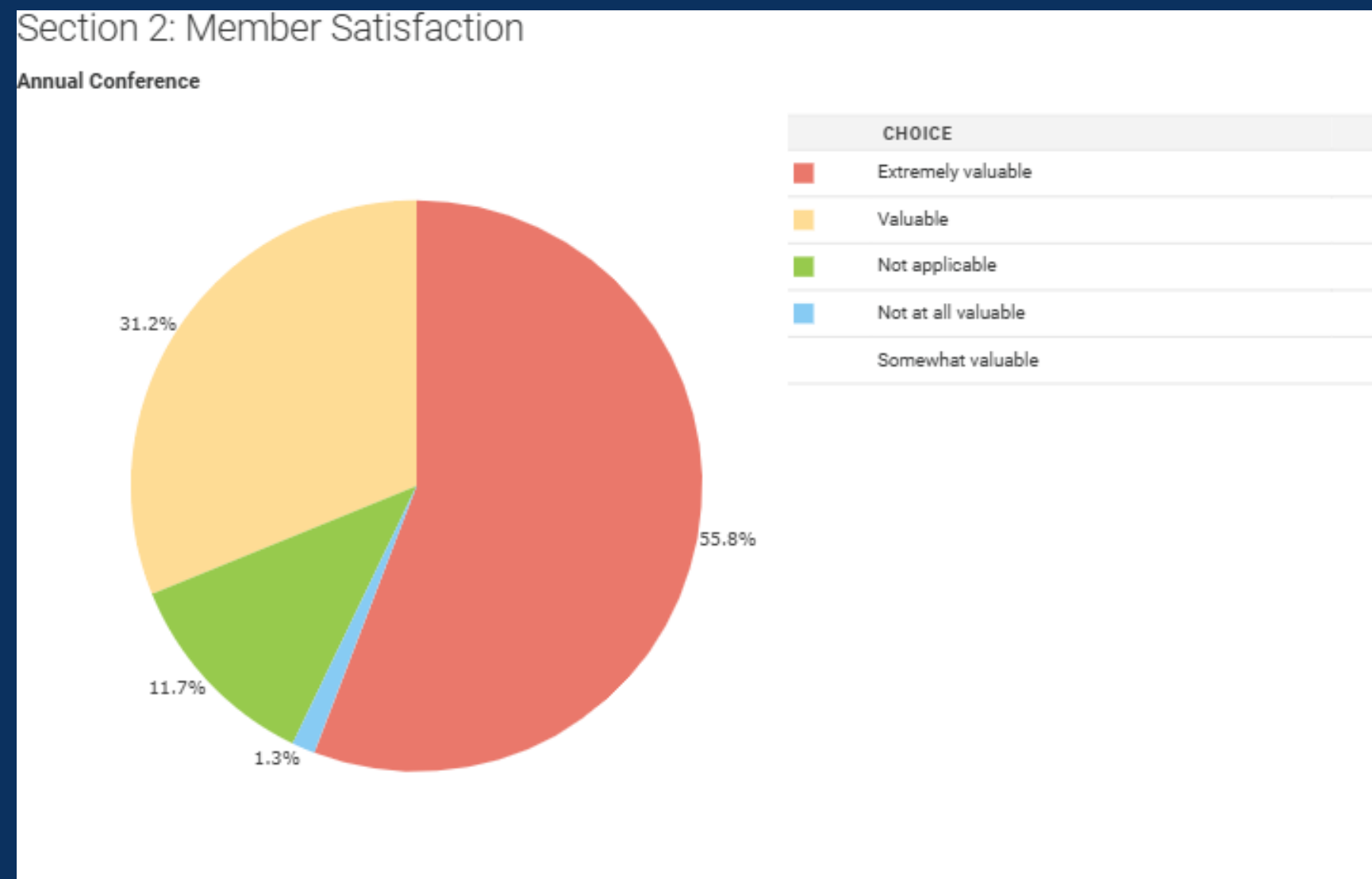


- About 87.1% of respondents are Very Satisfied or Satisfied with their Civitas Networks for Health Membership.
