
Draft HDU Framework Supplement Version 1 Available for Public Comment

This supplement builds upon the foundational <u>Health Data Utility Framework</u>, addressing the evolving needs of health data governance, interoperability, and value-based care within regions and states throughout the U.S.

Why Your Feedback Matters: We are inviting public comment to ensure this resource reflects the insights and priorities of a broad range of contributors, including health information exchanges (HIEs), HDUs, public health agencies, health plans, health collaboratives, and community organizations. Your input will help refine the framework to better support health data ecosystems and their partners.




J2 Interactive and Civitas Partner




 After creating your guest user account or signing into your Microsoft account, you should automatically be sent to Teams where you should see the following home page:






- On this home page, under the 'posts' tab, you will be able to start conversations that all


Program Background

- Extensive work has been done to identify and codify demographic data.
- To date, the focus of this work has been on race, ethnicity, and language (REL), sexual orientation and gender identity (SOGI), military status, pronouns, disability status, and relationship status data and there is desire from organizations such as AHIP to both deepen these standards and expand to additional exchange standards to inform culturally appropriate care.
- In early 2023, AHIP convened their Health Equity Workgroup to develop recommendations for additional demographic elements including language, relationship status, disability status, military experience, and spirituality.



Program Partners







Program Administrator – Responsible for development and execution of the project plan, partnership development and convenings, product delivery, and budget management.



Consultant and Standards Development SME – Provide subject matter expertise to inform prioritization and alignment activities in the initial phase of work. Provide input and education on HL7 processes and support refinement.

Patient Centered

Data Home® (PCDH)



Civitas Networks for Health Patient Centered Data Home®



PCDH is an initiative of Civitas Networks for Health members that puts into practice the vision that clinical data should be available whenever and wherever care occurs and "centered" around the patient to improve patient care.



In this model, all clinical data becomes part of the comprehensive longitudinal patient record in the HIE where the patient resides, called the Patient Centered Data Home.



Gravity Project Implementation Affinity Group

- Initiated in 2022, the Implementation Affinity Group aims to establish a piloting community that tests and validates Gravity Project standards.
 - 90-minute public calls on the last Thursday of the month 2:30pm-4:00pm ET.
- Accelerates real-world testing of the Gravity SDOH Clinical Care FHIR Implementation Guide (IG).
- Creates a forum to engage community-based organizations in standards-based data exchange with clinical systems.
- Demonstrates how to share clinical data to support upstream data use for population health, public health, quality improvement, and research.

Supporting Implementation of Gravity Social Care Standards Across New York State



Consultant and SME – Provide subject matter expertise to support the development of a standard set of functional and implementation requirements for the use of SDOH data across the SHIN-NY.




Program Sponsor – Provides leadership and strategic guidance and direction, provides input into program activities to ensure alignment with SHIN-NY goals.
